It is hereby notified to all students that the online enrollment for Odd 2025-26 session will commence by the end of this month. Additionally, this is to notify that the following category of students shall not be promoted to the forthcoming semester.

#### **A student will not get promoted to –**

1. The 3<sup>rd</sup>/5<sup>th</sup>/7<sup>th</sup>/9<sup>th</sup> semester if she/he has not enrolled in 2<sup>nd</sup>/4<sup>th</sup>/6<sup>th</sup>/8<sup>th</sup> semester respectively.
2. (i) the 5<sup>th</sup> semester if she/he has pending backlogs in 1<sup>st</sup>/2<sup>nd</sup> semester.  
(ii) the 7<sup>th</sup> semester if she/he has pending backlogs in 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup> semester.  
(iii) the 9<sup>th</sup> semester if she/he has pending backlogs in 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup>/5<sup>th</sup>/6<sup>th</sup> semester.
3. (i) the 3<sup>rd</sup> semester if she/he has pending backlog in any Sessional Course of 1<sup>st</sup>/2<sup>nd</sup> semester.  
(ii) the 5<sup>th</sup> semester if she/he has pending backlog in any Sessional Course of 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup> semester.  
(iii) the 7<sup>th</sup> semester if she/he has pending backlog in any Sessional Course of 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup>/5<sup>th</sup>/6<sup>th</sup> semester.  
(iii) the 9<sup>th</sup> semester if she/he has pending backlog in any Sessional Course of 1<sup>st</sup>/2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup>/5<sup>th</sup>/6<sup>th</sup>/7<sup>th</sup>/8<sup>th</sup> semester.

Candidates eligible for the Summer Term 2024–25 who intend to clear their pending backlogs — thereby enabling resolution of any consequent year lag — may be provisionally permitted to attend classes for the forthcoming semester. ***However, their class attendance will be officially registered only upon successful clearance of the pending backlogs during the Summer Term.***
